

#### INTRODUCTION

This is an agreement between Modern Pilates UK and you. These terms and conditions apply to your application for your training course, module or workshop and aim to outline your obligations as a student and our obligation to you.

#### **BOOKING**

- 1. All bookings must be accompanied by a **non-returnable deposit** or full payment (see fee sheet).
- 2. Bookings will not be accepted unless a deposit or payment has been received.
- 3. Bookings made on your behalf by your employer must be accompanied by an Official Purchase Order and your application form.
- 4. Balance payments are due 4 weeks before the course commences unless you are paying by standing order.
- 5. Balance payments not paid will result in the withholding of your Certificate/Qualification
- 6. Any fees paid and that are not used within one year of the date of payment will be forfeited.
- 7. You **must complete and return your application form** as it contains information that is required **prior** to your course commencing. Failure to do so could jeopardise you ability to join the course.
- 8. If you have answered **yes** to any of the Medical History questions you **must** enclose a letter from your doctor stating that he/she understands the nature of the course is vigorous physical exercise and it is acceptable for you to undertake and partake in the activities.
- 9. MPUK has the right to refuse your application if it deems the medical condition(s) you have disclosed may be aggravated by attending the course. MPUK also reserves the right to refuse entry to a course if you do not disclose a pre-existing medical condition.

All course bookings will be confirmed by us in writing and you have the right to cancel your booking and obtain a full refund of fees paid. This must be done within **7 days** of your booking. You must return all course materials and manual (recorded delivery) before we will refund the fees. Course materials not returned or received in a damaged condition will be deducted from the fees paid.
